Subject: Enquiry Notice – Initiation of Enquiry into disputes concerning conduct of elections and constitution of governing body of Zilla Cricket Sangham, Srikakulam – Calling for explanation – Reg.

3. Representations, objections, email communications and documents received by the Office of ACA from rival groups of office bearers of Zilla Cricket Sangham, Srikakulam.

Dear All,

The Andhra Cricket Association (ACA), taking note of the rival claims, objections and disputes concerning the conduct of elections, constitution and functioning of the governing body of Zilla Cricket Sangham, Srikakulam and in exercise of powers under Clause 2(n) of the Memorandum of Association read with applicable Bye-laws of ACA, constituted an Independent Three-Man Enquiry Committee to undertake examination and verification of records and to ascertain the factual and administrative position concerning the election and affairs of Zilla Cricket Sangham, Srikakulam.

Whereas, pursuant to the aforesaid constitution of the Three-Man Enquiry Committee and in accordance with the powers conferred thereunder, the enquiry proceedings are hereby initiated and in discharge of the responsibilities entrusted to it, the Committee has received and taken on record the representations, communications, records and other materials placed before it for consideration.

Upon preliminary consideration of the material presently available and for the limited purpose of conducting the enquiry in accordance with principles of natural justice, the Committee considers it necessary to call for explanations, records and responses from all the concerned office bearers / members / stakeholders in relation to the issues arising for consideration, including but not limited to the following:

- a. Issues relating to conduct and validity of election process,
- b. Issues concerning constitution and functioning of the governing body,

- c. Any departures from applicable Rules, Bye-laws, resolutions or established procedures and
- d. Such other connected matters arising from the materials placed before the Committee or that may emerge during the course of enquiry.

Accordingly, for the purpose of enquiry and before any findings or recommendations are arrived at, you are hereby called upon to show cause and submit your written explanation together with all supporting records and documents on and around the issues referred herein above.

Your explanation together with all supporting records and documents, if any, shall be submitted within **Seven (7) days** from receipt of this notice.

All concerned office bearers, members and stakeholders are expected to cooperate with the enquiry proceedings and furnish such explanations, records and materials as may be required by the Committee from time to time. It is needless to state that the Committee, if it considers necessary in the facts and circumstances of the enquiry and in accordance with principles of natural justice, may provide an opportunity of personal hearing and intimate the date and time therefor.

In the event of failure to submit explanation within the stipulated period, the Committee shall proceed further on the basis of the material available on record and continue the enquiry in accordance with law and applicable rules.

This notice is issued without prejudice and shall not be construed as expression of any final opinion or finding on merits.
