Subject: Publication of Final List of Contesting Candidates – Elections for the 5 posts of Officer bearers and 1 post of Councilor - Election AGM - ACA - Reg.

Dear All,

I had personally supervised the entire process of receiving representations and nomination forms cum affidavits, which was conducted on 3rd August 2025 at Registered Office of ACA at Mangalagiri Stadium, Guntur District, and at every stage of the election process, I have personally conducted and supervised the election process. The delegatee had only assisted in clerical and administrative aspects that required facilitation, under my direct supervision. The responsibility of overseeing the election process, scrutinizing nominations, and ensuring adherence to the rules and regulations remained solely with me. Accordingly, the delegatee is hereby dispensed-with and I confirm that the entire process, including the receipt of nominations and the thorough scrutiny of nomination forms and affidavits, has been completed solely by me, as per the regulations and prescribed procedure.

I further inform that as per the records and the election process conducted till date, 6 (Six) valid nominations were received, namely:

1. Sri. Kesineni Sivanath – Representing and nominated by Kurnool District Cricket Association – for the Post of President.
2. Sri. Bandaru Narasimha Rao – Representing and nominated by New Cricket Club, Guntur – for the Post of Vice – President.
3. Sri. Sana Sathish Babu – Representing and nominated by The East Godavari District Cricket Association – for the Post of Secretary.
4. Sri. Dandamudi Srinivas – Representing and nominated by The Krishna District Cricket Association – for the Post of Treasurer.
5. Sri. B.Vijaya Kumar – Representing and nominated by The Chittoor District Cricket Association – for the Post of Joint Secretary.
6. Sri. Danthu Gour Vishnu Tej – Representing and nominated by Vizianagaram Cricket Club – for the Post of Councillor.

The above-mentioned list of valid nominations was duly communicated to all members via email dated **07.08.2025**. Subsequently, a withdrawal window was provided for the candidates listed in the valid nominations, before **05:00 PM on 11.08.2025**.


It is further informed that none of the candidates have tendered any letter to withdraw their nomination forms within the stipulated timeframe. Upon personal and thorough scrutiny of the nomination forms and affidavits; I, in my capacity as the Electoral Officer, hereby publish the **Final List of Contesting Candidates** for the 5 posts of Officer bearers and 1 post of Councilor of Andhra Cricket Association.

It is relevant to inform that certain anonymous letters/ representations were received complaining w.r.t the Name of Representative of 'New Cricket Club, Guntur', where under the 'New Cricket Club, Guntur' had requested for change of its Representative and the said Representative had filed nomination for the post of 'Vice-President'. The undersigned in exercise of his duties and powers under Rule 37 of the Bye-laws of ACA, considered the request of the President and the Secretary of New Cricket Club to change the Representative of New Cricket Club, Guntur. The said change in no circumstance would alter the level playing field or would prejudice the rights of any of the participating candidates and also the Electorate (34 full members of ACA). But, nevertheless, since such anonymous complaints were received and in order to avoid unforeseen and disturbing elements threatening the peaceful process of election of ACA; it is just and prudent that the said issue requires deeper examination or re-consideration in terms of the Bye-Laws, and **hence, it is hereby notified that the election to the post of Vice-President and the vote of New Cricket Club, Guntur are kept in abeyance** and election to the other Four (4) Posts i.e. President, Secretary, Treasurer and Joint Secretary, and 1 Post of Councilor, shall be conducted as per the schedule and strictly in accordance with the Bye-Laws of ACA, on 16th August, 2025.

This communication is issued to officially announce the list of final contesting candidates for the forthcoming elections.

The Election AGM for the said elections remains scheduled to be held on 16th August 2025 at Vijayawada Club, Tadepalli, Guntur District.
