The Office of the Electoral Officer, Andhra Cricket Association (ACA), pursuant to the issuance of the schedule of election to the Two (2) elected posts of the Governing Council for the conduct of Andhra Premier League (APL - 2026) and in compliance with the relevant rules and regulations, issued communication on **12th March, 2026** regarding the receipt of authorizations from representatives of full member of ACA for preparation of Draft Electoral Roll. Objections against the Draft Electoral Roll released pursuant to receipt of applications were invited until **05:00 PM on 15th March 2026**, and the Final Electoral Roll was published on **16th March 2026** after receiving no objections.

The Office of the Electoral Office, Andhra Cricket Association after release of the Final Electoral Roll had scheduled the receipt of **Nomination forms cum Affidavits** on **23rd March 2026** between **02:00 PM to 04:00 PM** at at the **Andhra Cricket Association Administrative Office**, Krishnaveni School Road, Near NTR Circle, Patamata, Vijayawada from candidates intending to contest the said elections. The deadline for filing nominations for the said election was scheduled to be **on or before 04:00 PM on 23rd March 2026**, beyond which no nominations were accepted.

As per schedule and within the specified timeline, the Electoral Officer personally received only Two (2) duly filled nomination affidavits along with the necessary documents.

The Office of the Electoral Office, Andhra Cricket Association had scrutinized the nomination forms received within the scheduled timeline, verifying their compliance with the prescribed norms, rules and regulations on **23rd March 2026** from **05:00 PM to 06:00 PM** as per schedule. After a thorough examination of all documents submitted, the process of scrutiny is now completed, and the Office of the Electoral Officer hereby releases the List of Valid Nominations for the aforementioned elections.


- 1. SRI RAVU VENKATA SUJAY KRISHNA RANGA RAO** - Representing and nominated by Vijayanagaram District Cricket Association

It is further informed herein that the window for withdrawal of the nomination is open for the above-mentioned candidates to withdraw the application if, on or before **09:00 PM on 25th March 2026**. Upon completion of the said process, the final list of candidates contesting for the the Election to the Two (2) elected posts of the Governing Council for the conduct of Andhra Premier League (APL - 2026) will be released on **28th March 2026 at 05:00 PM**.

The Special General Meeting for the said election remains scheduled to be held on **05th April 2026**. This notification is issued for the strict adherence of all the rules and regulations governing the said election and as per the schedule.
