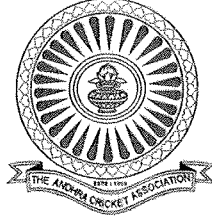

### DISCUSSION :

CEO informed the apex members about the receipt of the letter dated 07-02-2022 from the Commissioner of AP CRDA, Vijayawada. Further, he informed that the ACA procured land consisting of 20 Acres in Amaravathi Township at Rs.50,000/- per acre in the year 2000 for construction of Stadium, subject to condition that ACA shall complete the stadium work within the maximum period of 3 years. Further, the said condition is extended for three more years regularly. ACA also purchased 3.29 acres from VGTMUDA apart from earlier 20 Acres. As, ACA did not complete the stadium work within the stipulated period, CRDA issued the above letter with instructions to complete all the infrastructure facilities at the earliest.

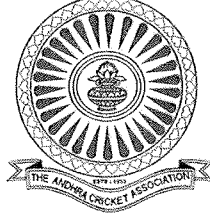

He also informed that he instructed the engineering department to call for the tenders for drainage and road works, and also informed that APEX body of ACA in previous meetings allotted a sum of Rs.7 Crores for the development works at Mangalagiri, mainly compound wall, drainage, roads and modernization of players dressing rooms. Further, proposed to appoint a third party agency to oversee the works taken up by ACA in a transparent manner.

The Finance Manager, ACA clarified that the audit work of IVRCL may not cause any obstacle for calling tenders.

Sri SR. Gopinath Reddy, Treasurer, ACA informed the Finance Manager to write a letter to IVRCL with a request to clear all of their material from the premises of Mangalagiri Stadium and give their further clarification about their accounts and transactions with ACA.

## RESOLUTION :

The House noted the progress about the Mangalagiri works and accepted the proposal of Sri SR. Gopinath Reddy, Treasurer, ACA and decided to utilize the allotted Rs.7 Crores for the above mentioned works such as compound wall, drainage, roads and modernization of players dressing rooms and also to appoint third party agency to oversee the progress of works taken up by ACA.

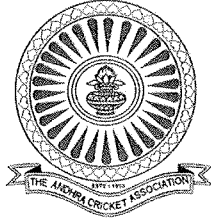

## DISCUSSION :

CEO, ACA informed the House that Sri Venkateswara University, Tirupati, allotted 30 Acres of land at Tirupati and entered into an MoU with ACA in the year 2013 with a condition to develop the infrastructure and facilities within 5 years from the date of MoU.

Since, some persons approached Green Tribunal, Chennai against the action of ACA in clearing some rare plants from the allotted site, and as per the orders of the Green Tribunal, ACA paid a penalty of nearly one crore of rupees to TTD. Further, the clearance orders from the forest department are required to proceed further with ground developmental works.

The forest department also written a letter to ACA to translocate available red sandal trees from the allotted land for which ACA requested the forest department to take up the work of felling of trees or translocating of the trees or implantation of trees in other area from the allotted area with an assurance to meet the expenses for that work. Further informed that on the request of ACA, MoU period is extended from 5 years to 12 years by the S.V. Universities so that ACA has to complete the infrastructure and other facilities on or before 2025.

Treasurer informed that he instructed Boys and Girls Cricket Association of Chittoor to pursue the matter with the forest department in order to start the work.

## RESOLUTION :

The House noted the same.

## AGENDA-4 :

Guntur in IA No.1100 of 2009 and 1101 of 2009 dated 03-08-2010 . Guntur United Cricket Club filed SOP 153 of 2009 and got interim orders from the Hon'ble High Court of AP in WPMP 274 of 2009 in WP 21134 of 2009 dated 25-09-2009. In both matters the courts have directed ACA to continue the above clubs as members of ACA till further orders. Thereafter, the both SOPs were dismissed in the year 2015 for default and immediately they filed restoration petition and both matters are pending before the III Addl. District Judge, Guntur.

After formation of new body of the Andhra Cricket Association as per the Lodha Reforms in the year 2019, the above two Clubs made a representation to the APEX body seeking re-affiliation to their Clubs as members in ACA as per the directives of Committee of Administrators dated 13-08-2019.

After due deliberations, the matter put for voting and decided.

## **RESOLUTION** :

Sri SR. Gopinath Reddy, Treasurer, ACA proposed the above two Clubs namely a) Kurnool Blues Cricket Club Reg. No.144 of 2008 b) Guntur United Cricket Club Reg. No.218 of 2008 to re-affiliate them as full members in ACA and the said proposal was supported by 1) Sri P. Sarath Chandra Reddy, President, ACA 2) Sri R. Dhanjay Reddy, Council, ACA 3) Mrs. Anuradha Nirmal Kumar, Member 4) Sri A. Gowtham, Member 5) Sri VVSSKK Yachendra, Vice President, ACA and 6) Md. F. Rahaman, Member also supported the proposal if there is no legal complication.

Hence, it is unanimously resolved to re-affiliate a) Kurnool Blues Cricket Club Reg. No.144 of 2008 and

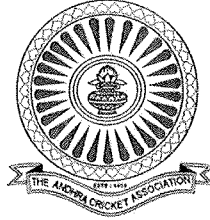

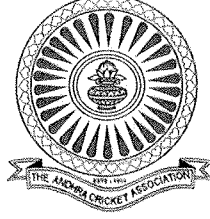
