Dear Members,

In view of the Elections for the Office bearers and Councillor to the Andhra Cricket Association, scheduled to be held on 08.09.2024 (8th September 2024), the undersigned Electoral Officer deems it fit to issue the following directions with regards to the location of the Voting being held on the said date.

Due to the unprecedented floods that have affected Parts of the NTR, Krishna and Guntur districts of the State of Andhra Pradesh District, the undersigned Electoral Officer exercising the powers under clause 4(b) of the Preamble of the Elections, hereby informs the members that the Election and the Voting will now take place at ***The Lemon Tree Hotel, Vijayawada*** instead of the Vijayawada Club, Tadepalle due to the Floods having affected the previously selected location.

It is duly informed that, any member who is eligible to vote, and wishes to exercise his right to vote, shall be present at ***the Lemon Tree Hotel, Vijayawada*** on 08.09.2024 at the time specified in the Reference 1st Cited and shall exercise their right to vote. It is further clarified that there is no change in the Election Schedule that was notified earlier but merely the location has been Shifted to ***the Lemon Tree Hotel, Vijayawada***.

It is further informed that, any person who is not a member but wishes to be present on the day of the Election, physically shall seek the permission of the undersigned Electoral Officer, 48 Hours prior to the Voting Day and only upon grant of such permission

will they be permitted into the Premises. It is further clarified that as informed earlier, the option to avail the right to exercise the vote shall be made available through Hybrid mode.

This is for Information and Record. It is clarified that the undersigned Electoral Officer, along with Sri. SMN Rohit Varma, General Manager -Cricket Operations, ACA and Sri.N.Ashwani Kumar, Advocate, High Court of Andhra Pradesh would be present physically on 08.09.2024 at ***The Lemon Tree Hotel, Vijayawada*** for the smooth conduct of the Election Process.

It is further informed that, on the day of Polling, the Special General body Meeting that is to be conducted shall be convened and thereafter a Chairperson is to be elected, thereafter, the undersigned Election Officer will announce the results of the preceding Election and the presentation of certificates to the Elected Members will take place. Further, the newly elected body will take charge and take further steps in pursuance to the same. This is for information of the members.
